Please find enclosed the requests for amendments to the Articles of Association received by the General Secretariat of UFE in time, which according to the Articles of Association have already been announced to the member associations with Information No. 8/2010.

According to § 7 Sect. 2, for amendments to the Articles of Association, the consent of 2/3 of the votes present is required.

Appendix to Point 5

Submission for amendment to the Articles of Association 1

Submitter:

BDZ (the trade unions represented on the Presiding Board of UFE

support this submission)

§ 8 Sect. 1 Sentence 1 is to receive the following wording:

The Presiding Board consists of the President and 5 Vice Presidents, of whom at least respectively 2 must represent the tax administration and the customs administration.

-The previous sentence 2 is no longer applicable.

Justification:

The amendment to the Articles of Association is justified by Klaus-Hilger Leprich (BDZ) with the fact that in an increasing number of member states of UFE, the tax and customs administrations are merged and the member unions organise the tax as well as the customs areas correspondingly.

Submission for amendment to the Articles of Association 2

Submitter:

The trade unions BDZ, DSTG, DTS, garaNto, SNUI, and PCS rep-

resented on the Presiding Board of UFE

§ 8 Sect. 1 is amended by the following sentence:

Furthermore, one representative of the organisation of UFE with the highest number of members, which is not represented on the Presiding Board on the basis of the election, is automatically co-opted as a Vice President of the Presiding Board of UFE.

§ 8 Sect. 2 is amended by the following sentence:

The term of office of a co-opted Vice President corresponds to the term of office of the Presiding Board elected.

Justification:

According to a decision of the Committee of UFE practiced for 40 years, one representative of the trade union of UFE with the highest number of members, which is not represented on the Presiding Board on the basis of the election, is or will be, respectively, co-opted onto the Presiding Board.

With the amendment to the Articles of Association, this de factor condition is to be reflected in the Articles of Association.

The amendment of § 8 Sect. 2 is a consequence of the amendment to the Articles of Association in § 8 Sect. 1 and clarifies, that the duration of the cooption corresponds to an elected term of office.

Submission for amendment to the Articles of Association 3

Submitter:

The trade unions BDZ, DSTG, DTS, garaNto, SNUI, PCS repre-

sented on the Presiding Board of UFE

If necessary, the Committee may co-opt further members onto the Presiding Board. During the term of office, the Presiding Board itself shall also be entitled to this right.

Justification:

As the reason for this amendment, it has to be stated that trade unions joined UFE over the past years (e.g. Spain, Portugal, Greece, Czech Republic), which previously had not been represented in UFE. In order to meet the thus grown multitude of special regional interests and mentalities, it may be appropriate to expand the Presiding Board by representatives from these European regions.

Submission for amendment to the Articles of Association 4

Submitter: The trade unions BDZ, DSTG, DTS, garaNto, SNUI, PCS represented on the Presiding Board of UFE

§ 10 Sect. 4 receives the following wording:

This shall also apply to the amendments to the Articles of Association decided in Paris on 26 September 1976 and in Luxembourg on 22 September 1988, in Helsinki on 21 September 1999, in Brussels on 7 September 2000 as well as in Lisbon on 23 September 2010.

Justification:

Editorial adjustment due to the amendments to the Articles of Association passed.

Election of the new Presiding Board (§ 6 Sect. 3, No. 3 of the Articles of Association)

According to § 8 Sect. 2 of the Articles of Association of UFE, the Presiding Board is elected for a term of 4 years. The term of office of the Presiding Board elected at the 43rd Committee Congress of UFE in Brussels on 28/29 September 2006 therefore ends in September 2010, so that the routine elections must be held.

Election of the President of UFE

The President of UFE, Dieter Ondracek, who took over this office in 1999, and thus has been the President of UFE for 11 years, will no longer run for office for reasons of age. According to the information present at the General Secretariat so far, the Vice President of UFE and Chairman of the Tax Commission of UFE, our colleague Serge Colin (SNU! – France) as well as our colleague André Friden (LDG – Luxembourg) will run for the office of President.

Election of the Vice Presidents

For the office of Vice President run again our colleagues Jorn-Rise **Anderson**, Klaus-Hilger **Leprich** and Peter **Lockhart**. Should he not be elected President of UFE, our colleague Serge **Colin** will run for the office of Vice President again.

Our colleague Giordano Schera (garaNto – Switzerland) will no longer run for office for reasons of age, and our colleague Nico Goor is not allowed to run for office anymore, since his association, the Dutch NCF withdrew from UFE as of 1/1/2010.

Their first-time candidacy as Vice Presidents announced Gabor **Holecz** (VPFSZ – Hungary), Helder **Ferreira** (STI – Portugal), and should our colleague André **Friden** (LDG – Luxembourg) not be elected President, our colleague Fernand **Muller** (SCC – Luxembourg).

According to the Articles of Association of UFE, one representative of the biggest member association, which is not represented on the Presiding Board, is automatically co-opted onto the Presiding Board. DSTG will make use of this right to co-option and send the Vice President of DSTG, Anne **Schauer**, to the Presiding Board. She knows the UFE from her activity as a functionary in the UFE youth programme.

Election of the new auditors

According to § 10 Sect. 1 of the Articles of Association, the 3 auditors are elected by the Committee for the duration of the term of office of the Presiding Board.

Since the term of office of the Presiding Board expires, now also the 3 auditors, who according to the Articles of Association must not be members of the Committee as delegates entitled to vote, have to be newly elected for the duration of 4 years.

The previous auditors Peter **Wirth** (PVB – Switzerland), Pierre **Pezzotta** (LDG – Luxembourg) as well as Alain **Leblanc** (SNCD – France) have signalled their willingness to run for office again.

addition to, respectively, a membership in a general European umbrella union via a national umbrella union.

Only as a marginal note: the German Tax Union is organised in CESI via its national umbrella union, the German Civil Service Federation.

The President of CESI and Chairman of the German Civil Service Association, Peter Heesen, will give a welcome address in the opening of the Committee Congress on 23 September and will be available for questions.

It has not been planned to burden the member unions of UFE with additional premiums for the possibility of the cooperation with CESI. It has rather been planned to pay a lump-sum from the budget of UFE to CESI as compensation for the possibility of the members of UFE to participate in CESI meetings.

Election of the New Chairmen of the Tax and Customs Commissions

The Chairmen must be elected or co-opted members of the Presiding Board.
